(2018) shifted the focus to educational anthropology, uncovering gaps in acknowledging its importance in grassroots research throughout India. Their work connected these gaps to concerns about diversity in education among tribal and marginal communities. The argument presented supported the integration of educational anthropology in policy-making, curriculum construction, and teacher training to foster responsible citizenship and better integration of peripheral tribal communities. Kumar and Yadav (2018) delved into the challenges faced by non-tribal dairy farmers in Jharkhand, highlighting the need for targeted policy implications to enhance their standard of living. The study emphasized the importance of interventions by NGOs and the District Administration in addressing the socio-economic needs of non-tribal rural women engaged in animal husbandry practices. Narayan and Chakraborty (2019) conducted a content analysis of the educational scenario of tribes in Jharkhand, shedding light on literacy rates, educational status, and gender disparities. The paper critically examined government intervention and achievements in the field of education, positioning tribes in Jharkhand as a case study. This work provided valuable insights into the challenges faced by tribal communities in accessing quality education. Surya Pratap's (2019) study explored the status of tribal education in Uruguttu, a village in Jharkhand. Through a quantitative methodology, the research assessed infrastructural facilities, discrimination in the education sector, and related aspects. The findings, presented pictorially and statistically, provided a comprehensive understanding of the tribal education landscape. Shep (2019) delved into the historical biases and stereotypes faced by Scheduled Tribes (Adivasis) in India, leading to their alienation in education and high dropout rates. The paper highlighted the importance of recognizing the diversity within tribal communities and addressed the psychological and social challenges they encountered.

Thamminaina et al.'s (2020) systematic review focused on the education of girls from Particularly Vulnerable Tribal Groups (PVTGs) in India. The study revealed the lack of progress in PVTG girls' education despite the global commitment to SDG-4. It emphasized the need for research and policy frameworks to address the specific challenges faced by this vulnerable group. Kumari et al. (2020) shifted the focus to corporate contributions to socio-economic development, particularly the role of CSR in supporting tribal artisans in

Jharkhand. The study compared CSR initiatives of Jindal Steel and Power Ltd. and Tata Steel Ltd. in promoting tribal handicrafts. The exploration of the impact of such projects on the socio-economic development of local communities provided insights into the potential positive effects of CSR activities. Mecham's (2020) study explored the implementation of the Forest Rights Act (FRA) and its impact on Adivasi communities heavily dependent on forests for their livelihoods. The research highlighted the challenges in FRA implementation, particularly the lack of official documentation for community petitions, leading to the degradation of resources and increased vulnerability of these communities. Minz's (2020) research delved into the policies and programs undertaken by the government of India for the growth and development of the tribal community. Despite continuous efforts, the study suggested that the tribal population continued to grapple with underdevelopment and struggled for basic necessities.
